

1993 Annual Business Meeting
Bettendorf, IA
February 17, 1993

The annual business meeting was called to order by President Mike McGhee. Forty-nine members were in attendance.

The minutes from the past meeting were read. Tom Gengerke made a motion to approve the minutes as read. Mike Mason seconded the motion and it passed.

Paul Brouha, Executive Director, of the American Fisheries Society was introduced and given the floor to address the Chapter. Scientific information assimilation, professional enhancement, and resource conservation development and wise use were the three main topics addressed by Mr. Brouha.

The Treasurer's report was summarized and concluded a balance of \$3,286.39 as of 15 September 1992.

Committee Reports

Membership Committee Chair Dave Marolf was unable to attend. President Mike McGhee noted that last year the Chapter had sixty-two paid members. The last newsletter was mailed to around one hundred people including past members and potential members.

REAP Committee Chair Dick McWilliams reported that a fight for funding was under way in the lowa Legislature. The Governor's recommendation was for \$8.5 million. The REAP Alliance requested the same \$150 donation as last year from the Chapter. McWilliams made a motion for \$150 continued contribution by the Chapter to the REAP Alliance. Mike Mason seconded the motion and it passed.

Continuing Education Committee Chair John Pitlo reported that last year workshops included Fish Health Assessment by Ronald Goede and Computer Applications by Dick Frie. John received a filer from John Lyons, NCD President, on what some other states have done along the lines of continuing education. Topics that other states have done include: Statistic Application in Fisheries and Computer Application of Multivariate Analysis both by Paul Hinze; Computer Modeling of Fish Growth by Don Periera; Use of Catch Effort, Stock, and Condition Indices in Fish Management by Dave Willis and Chris Guy; Larval Fish by Nancy Auer; and Non-Parametric Statistics by Dave Bowden. By a show of hands a priority list was developed to give John some direction on which courses to pursue. It was decided that it works best to go through the Fish and Wildlife Service and use DJ money if available.

Resolution Committee: Mike Mason read a resolution concerning a proposal by Governor Terry Branstad and the Iowa Department of Management that would limit the Iowa DNR to 779 employees. With some minor word changes, the resolution was adopted by the Chapter and is to be sent to fifty Senators, one hundred Representatives, and the Governor. The resolution was seconded by Steve Waters and passed. Don Bonneau made a motion that a similar resolution be drafted concerning the proposed constitutional amendment to protect the fish and wildlife trust fund. Seconded by many and passed.

Old Business

Revision of the Chapter By Laws was approved by the Parent Society.

New Business

Advocacy: President Mike McGhee pointed out that there are some groups that might need the support of the American Fisheries Society both as members and financially. Groups like Iowans For Better Fisheries are working hard on some common issues such as protection of the fish and wildlife trust fund and returning the DNR to a Conservation Commission. Discussion followed on what we as a Chapter can do to help IBF with their lobbying efforts. Chris Larson made a motion that the Chapter donate \$500 to Iowans For Better Fisheries to become sustaining members and to help defray lobbying cost. Seconded by Larry Mitzner and passed.

AFS Cookbooks: President Mike McGhee presented the Chapter with a copy of Sea Fare-The Official American Fisheries Society Cookbook, Volume One. The cookbook includes the favorite recipes of members of the Fish Culture Section and interesting folklore, stories, and facts about commercial fishing and fish. A discussion followed on the possible fund raising potential. Mike Mason made a motion that the Chapter purchase fifty copies to sell. Seconded by Tom Gengerke and passed. The cookbooks will be sold for \$15 plus shipping.

Ken Carlander's Book Vol. 3: Volume three is ready to be published but needs to be retyped in a different format. The cost of doing so could be as much as \$2,000. Larry Mitzner pointed out that this is a worthy cause but we are not the only source of funding. He mentioned the NCD as one possibility. It was also noted that other sections within the AFS such as the Education and Fish Management Sections may have funds available for this. Tom Gengerke made a motion to allow the EXCOM to donate up to \$250 for reformatting Ken Carlander's book volume three after all other avenues of funding have been pursued. Seconded by John Pitlo and it passed.

Student Membership: President Mike McGhee reported that student participation was discussed at the Toronto EXCOM meeting. A discussion of how we can target students included the possibility of holding our annual meeting in Ames, having a student best paper award, and/or providing money to get students to the meetings. Bob Summerfelt pointed out that there are only twelve seniors in fisheries at ISU and four of them are already members. His graduate students are members. Theresa Blackburn mentioned that there are small schools in lowa that we may be overlooking. Theresa volunteered to gather addresses of these schools so we can get our newsletter to them.

Next Meeting: The possibility of holding a joint meeting with the Nebraska and Dakota Chapters was discussed. Sioux City would be the likely meeting place. Steve Waters made a motion that the Chapter pursue the possibility of holding the 1994 meeting with the Nebraska and Dakota Chapters. Seconded by many. The motion carried.

Adjournment: John Pitlo made a motion to adjourn the meeting. Mike Mason seconded the motion. The meeting was adjourned.

RESOLUTIONS ADOPTED BY THE IOWA CHAPTER OF THE AMERICAN FISHERIES SOCIETY

Whereas, the Iowa Executive and Legislative Departments have attempted to transfer Fish and Game trust fund monies to the general fund; and

Whereas, the 1992 General Assembly and the 1993 Senate have agreed, by majority, to submit a constitutional amendment to the people of lowa that would restrict the expenditure of license fees and all other sources of revenue arising under the Fish and Wildlife Division solely for fish and wildlife purposes; and

Whereas, the General Assembly has recognized that the Fish and Game trust fund should not be diverted to the general fund.

Therefore, be it resolved that the lowa Chapter of The American Fisheries Society appeals to the House; and in particular the House State Government Committee and its chair, to approve HJR 3 and allow the proposed amendment to be voted on by the people.



Whereas, a proposal by Governor Terry Branstad and the Iowa Department of Management would limit the Department of Natural resources to 779 employees, 81 fewer than that now authorized by the Iowa Legislature; and Whereas, the reduction fails to take into account the specific duties of the positions eliminated and the effect this would have on DNR programs; and

Whereas, fifteen of the proposed positions that would be eliminated occur in the Fish and Wildlife Division; and

Whereas, funding for the Fish and Wildlife Division is derived from license fees and the Federal Ald in Wildlife and Sport Fish Restoration Programs and not from state taxes; and

Whereas, the Fish and Game Trust Fund is solvent and can absorb the costs of these positions; and

Whereas, cuts in programs would be unfair and have negative impacts on programs supported by the 1.6 million persons who participate in fishing, hunting and wildlife associated recreation in lowa and annually expend more than \$888,000,000 in pursuit of these recreational activities.

Therefore, be it resolved that the lowa Chapter of The American Fisheries Society opposes the recommendation of the Governor and the lowa Department of Management and urges that they reconsider their down-sizing proposal.

Be it further resolved, that the lowa Chapter of The American Fisheries Society appeals to the lowa Legislature to critically examine this down-sizing proposal and its impacts on current and future Iowa Department of Natural Resources Fish and Wildlife Division programs.

REAP ALLIANCE by Dick McWilliams

The REAP Alliance is continuing work on budgetary matters, specifically trying to work with the legislature to increase REAP funding to somewhere near the original goal. This winter will bring the REAP assemblies and meetings. We will need to have people at these meetings and encourage citizen participation to see that funding of REAP is maintained,

There is a little confusion about the REAP budget for last year and this year. The \$900,000 from last year's budget reverts to the general fund. The following are excerpts from two articles by Kevin Szcodronski from REAP, Vol. 5, Number 2.


After all was said and done, the 1993 annual meeting held in Bettendorf netted the Chapter \$78.81. This figure does not include revenue from Chapter dues.

STUDENT TRAVEL GRANT PROGRAM

North Central Division (NCD) President John Lyons and the Executive Committee have allocated \$500 in discretionary funds to support a Student Travel Grant Program in 1993. The purpose of this program is to provide funding to facilitate student travel to the annual NCD meeting that is held in conjunction with the Midwest Fish & Wildlife Conference. The program is designed to assist students who might not otherwise be able to attend the meeting. "It is not our purpose to establish an award given to recognize outstanding student research or service to the AFS or its subunits."

The NCD will award up to 5 travel grants (maximum of one per chapter) to provide financial assistance for student members. The Division will provide \$100.00 for each selected student, which will be matched by a minimum \$100.00 contribution from the student's chapter.

NOMINATION PROCEDURES

- 1. Each chapter will be permitted to nominate one student. Criteria for selection of chapter nominees will be handled by each nominating chapter.
- 2. Nominations should be forwarded to the Chair of the NCD Student Affairs Committee by each chapter president. Each nomination should include a letter from the student nominee that includes: students name, address, telephone number, educational institution, department, degree level, a short description of current research, reasons for wishing to attend the meeting, a copy of submitted presentation abstract (if applicable), and a copy of the acceptance letter from the program chair (if received).

The chapter president should send a letter that verifies that the chapter will provide at least \$100 directly to the student in a timely manner. The deadline for forwarding the nominations will be September 30, 1993. Funds provided by the NCD to selected grant recipients will be sent directly to the student.

- 3. A committee or representatives from the Division's Student Affairs Committee, Awards Committee, and an officer of the NCD will be responsible for evaluating nominations and selecting grant recipients. This committee will evaluate applications based on reasons for wishing to attend the meeting.
- 4. Grant recipients should plan to attend the NCD Business Meeting to be held during the 1993 Midwest Fish & Wildlife Conference. In addition, grant recipients should plan to represent student members of their chapter at the NCD Student Affairs Meeting to be held during the Midwest Fish & Wildlife Conference.
