### Awards

An announcement will be coming out soon via email and on the NCD website for how to nominate individuals for our awards of excellence and meritorious service, as well as for chapters to nominate themselves for Most Active Chapter and Best Communications awards. Winners will be announced at the 2023 Midwest Fish and Wildlife Conference.

### NCD leadership nominations

We are currently seeking nominations for people to join the leadership of the North Central Division. This is a three-year time commitment, moving from president-elect to president to past-president during the term. This is a great way to learn more about AFS and influence the direction of the society. It is also a way to develop broader networks within our profession. The time commitment isn't as big as you might think; quarterly NCD excom meetings are virtual, as are quarterly meetings with chapter presidents and technical committee chairs. In-person attendance at the Midwest Fish and Wildlife Conference and the parent society conference are strongly encouraged, and NCD funding is available to assist officers with travel when needed. Interested people can discuss it with current past-president Mark Finzel, who chairs our nominations process.

### 2023 Midwest Fish and Wildlife Conference

State chapters will also be giving Joan Duffey travel awards to students. Application processes for those awards will be announced by chapters, and NCD provides a financial match up to \$200 per chapter.

Planning is well underway for the 2023 parent society meeting in Grand Rapids, MI. The North Central Division awards are now seeking nominees!

### **Most Active Chapter Awards**

Two awards will be given to the North Central Division Chapters that have carried out the most active programs of enhancing professionalism and fisheries science, relative to its size and the geographic distribution of its membership. Most often, members will nominate their own chapter. Nomination materials should include the number of members, names of officers, number and type of meetings, special activities, recruitment activities, and a brief (1 page) description of what makes this chapter an active and important contributor to the NCD, AFS, and fisheries profession. Additional materials of support may also be included. Large Chapters include Illinois, Mid-Canada, Michigan, Minnesota, Missouri, Ohio, Ontario, and Wisconsin, and small Chapters include Dakota, Indiana, Iowa, Kansas, and Nebraska.

### **Most Active Student Subunit Award**

This award will be given to the North Central Division student subunit that has carried out the most active program in developing interest among undergraduate and graduate students in fisheries science and fulfilling the mission of the American Fisheries Society. Most often members will nominate their own subunit.

### **Best Communications Awards**

This award will be given to the North Central Division Chapter that has developed the most efficient, useful, and attractive newsletter and website to disseminate information to its members. Both printed and electronic newsletters will be considered. Submissions should include copies of two or three of the Chapter's most recent newsletters and a brief description of the newsletter, including frequency of publication, readership, and primary means of distribution.

### **Fisheries Excellence Award**

This award will be given to a North Central Division member who has made an outstanding contribution to the fisheries profession. This contribution may be a single activity or a collection of achievements over the individual's career. Former Division members may be nominated if most of their work occurred while they were NCD members. Nominations should include the names and signatures of at least 2 nominators, a brief (1 page) biographical sketch of the nominee, a brief (1 page) narrative of significant contributions made by the nominee, and copies of any additional materials to support the application.

**Applications for all 2022 awards are due December 4, 2022.**

## Committee Reports

### Walleye Technical Committee:

Jason DeBoer – WTC Chair

The Walleye Technical Committee (WTC) has been busy during the past year. We returned to the Iowa Lakeside Laboratory on Lake Okoboji for an in-person joint summer meeting with the Esocid Technical Committee (ETC) and Centrarchid Technical Committee (CTC) on July 18-20, 2022. We finished publishing a special section in the North American Journal of Fisheries Management from our virtual 2021 Midwest Fish and Wildlife Conference symposium entitled “Effects of System Change on North American Percid Populations.” Efforts to raise financial support to help cover publication costs were successful, totaling \$15,550 from state AFS chapters, DNRs, and the AFS Education Section, with additional funds from the NCD. We’re planning for our joint WTC/ETC/CTC business meeting (Feb 12) at the Midwest Fish and Wildlife Conference in Overland Park, KS on February 12-15, 2023. ### The Walleye Technical Committee is now seeking applications for our annual student travel grant: the Percid Award



**Purpose:** To financially assist one or more students conducting research of interest to the Walleye Technical Committee (WTC).

**Description:** A travel grant of \$300 from the WTC of the North Central Division of the American Fisheries Society for up to three students to attend the Midwest Fish and Wildlife Conference.

**Eligibility Criteria:** The recipient(s) of this award must be currently enrolled in a college or university for an undergraduate or graduate degree program. Preference will be given to those involved in research of interest to the WTC.

**Documentation required:** An application letter that includes: student’s name, address, telephone number, educational institution, department, degree level, a short description of current research, reasons for wishing to attend the meeting (paper or poster presentation, pertinent paper session, sub-unit business and/or technical meetings), and reasons why financial assistance is needed.

**Selection Criteria:** The Executive Committee of the WTC will evaluate applicants based on the following criteria:

- a. AFS involvement (reasons for attending the meeting).
- b. Relevance of research to the goals of the WTC.
- c. Number of applications and current funding levels.

**Frequency of Award:** The WTC will select up to three recipients each year. Multiple applicants from the same state will be handled at the WTC’s discretion, given the student’s state/province AFS chapter will be asked to match the award, but is under no obligation to do so.

**Deadline:** The deadline for receipt of completed applications by the WTC Chair is December 31, 2022.

### **Centrarchid Technical Committee:**

The Centrarchid Tech Committee held quarterly meetings on Feb 13, May 25, and July 20 in 2022. Our next meeting will be held next Wednesday, November 2. We are working with Matt Diana to participate in the Midwest Glacial Lakes Partnership 6-hour virtual webinar in February 2023. Further, we are planning on requesting funds from NCD to pursue various means of increasing membership in the CTC, to include more student travel grants for students presenting centrarchid-related research and money for production of merchandise to increase visibility of the CTC. At our next quarterly meeting we are voting on designs provided by a volunteer artist for our CTC-specific t-shirts that will be printed using the NCD Merchandise “Store” set up by Drew Holloway. We will hold our annual meeting at the Midwest Fish and Wildlife Conference in February both virtually and in-person.

## NCD Chapter Reports

### Missouri Chapter Update Jacob Westhoff—President

The most active committee with MOAFS over the last year was the Rivers and Streams Technical Committee. In January, they assisted Stream Teams United with a stream advocacy workshop where they were able to interact with 30+ interested stakeholders. Members also participated in the Clean Water Day at the Capitol, which provides a platform for interacting with partner organizations and legislators at the state level. In March, members participated in the “Dome Life” event which involved river cleanup of 26 miles of the Meramec River and allowed us to interact with more than 100 people through our informational booth where we displayed live fish and crayfish. In September, members attended the River Soundings Conference to interact with partners and share the message about what AFS does. Finally, there was a committee meeting where local biologists, researchers, and university faculty presented information on recent stream-related efforts in Missouri.

The MOAFS President also meet with two student subunits in October to share a presentation on the benefits of AFS involvement and all the opportunities it provides. The other significant update is that our outreach and education effort to produce a series of posters displaying all 220+ fish species found in Missouri is nearing completion. Posters should be ready to distribute and sell in early winter of 2023.

### Michigan Chapter Update

The Michigan Chapter of the American Fisheries Society (MI AFS) held an in-person meeting in March at Lake Superior State University that included a workshop on careers in natural resources, a plenary presentation by Dr. Bo Bunnell on restoration of coregonines in the Great Lakes, contributed oral presentations, and a poster presentation social.

More recently, MI AFS established a Diversity, Equity, and Inclusion Committee. Inaugural committee members include Tracy Galarowicz (co-chair), Dana Castle (co-chair), Kyle Brumm, and Lydia Doerr. The MI AFS Executive Committee and DEI Committee are currently working together to establish a mission statement for the committee and procedures to facilitate communication between the Executive and DEI committees.

The next AFS conference will be held in Grand Rapids, MI, August 20-24, 2023. Thankfully many members of the AFS Michigan Chapter have volunteered to make this meeting a success! Jennifer Johnson, President-Elect, is co-lead on Project and Program Management along with her colleagues Doug Larson (Past President) and Patrick Hanchin. Critical lead positions have been graciously filled by Stacey Ireland (Continuing Education), Jesse Wesolek and Jessica Mistak (Spawning Run), Jason Fischer and Shaley Valentine (Student Activities), Jory Jonas and Dana Castle (Diversity & Inclusion), and Tracy Claramunt (Fundraising). Of course, many more have stepped up and volunteered and the MI Chapter would like to thank each member for their time! MI AFS will gladly accept additional volunteers if members are interested.

MI AFS provided two student travel awards to Ben Kline (MSU) and Kelly Hoyer (CMU) to attend and present at the Joint Aquatic Sciences Meeting held in Grand Rapids, MI, in May. Each student was awarded \$1,000 to offset travel and registration fees associated with the conference. Annual awards including the Leonard, Hazzard, Grayling, and Cisco were all awarded at the annual MI AFS meeting held in early 2022. Jessica Mistak (MI DNR), the 2021 recipient of the MI AFS Cisco Award, also received a Meritorious Service Award from North Central Division of AFS and the 2022 Emmeline Moore prize, which she was awarded in Spokane, WA, at the annual meeting. Our Continuing Education Committee has granted three travel awards totaling \$350 in addition to free registration so far in 2022. The Continuing Education Committee holds up to 25% of seats for free student registration. If you are a student, please consider applying for these awards!

The Continuing Education Committee of MI AFS has organized three workshops since our natural resource careers workshop in March. First, a Freshwater Mussel Sampling and Identification Workshop was held 7-8 September Grand Rapids. The course was instructed by Joe Rathbun (retired aquatic biologist), Scott Hanshue (retired fisheries biologist), Dr. Renee Mulcrone (ASTI Environmental), Jessica Pruden (USFWS), Elle Gulotty, Kesiree O'Brien, and Cleyo Harris (MI DNR), and drew 16 attendees including 3 students. The workshop included classroom and field instruction to allow students to practice identification on live specimen and to see examples of sampling techniques and designs.

### Michigan Chapter Update

A Smith-Root Electrofishing Principles and Safety Workshop was held in Gaylord on 27-28 September. The course, instructed by Patrick Cooney, drew 16 participants including 3 students. This workshop included classroom instruction held at the University Center of Gaylord and field instruction at the Michigan DNR Gaylord fish shop with an overview of boat electrofishing followed by backpack and barge electrofishing in the Sturgeon River near Wolverine.

Data Manipulation and Visualization Fundamentals using the Tidyverse in R is a 2-day virtual workshop to be held 7-8 November, instructed by Shaley Valentine (SIU) and Garrett Johnson (USFWS).

MI AFS business has also been focused on planning a 2023 joint chapter meeting with the Michigan Chapter of The Wildlife Society, updating committee appointments, migrating our website to AFS hosting, and revising our chapter's bylaws.



## NCD News

Lee Charles Redmond, of Lohman, Missouri, passed away at the age of 83 due to heart failure on September 20, 2022.

He worked for the Missouri Department of Conservation (MDC) for 37 years as a fishery research biologist, fisheries management supervisor, and as an assistant fisheries division chief, before his retirement in 2000. He was widely recognized as an expert in the art and science of warm water fisheries management.

He implemented size limits on lakes throughout Missouri and played a major role in establishing one of the first urban fishing programs in the nation. He also drafted the original Municipal Lakes Program for the state of Missouri, which evolved into the highly successful Community Assistance Program. He worked successfully to provide additional federal funds to states for sport fishing and used those funds for Missouri to initiate a new stream program that became known as Streams for the Future.

Lee authored and co-authored several papers as well as organizing national symposia on the subject, and contributed a chapter in a book entitled, "Reservoir Fisheries Management – Strategies for the 80's," a summary of a National Symposium on the Managing of Reservoir Fishery Resources.

Meanwhile, he practiced what he preached--and went fishing.

Lee was also a leader in the American Fisheries Society (AFS).

He joined the Society in 1962, became a certified Fisheries Scientist in 1972, and a Lifetime member in 1981.

He was a Charter Member of the Missouri Chapter, where he served as Secretary Treasurer for two years.

He served as President of the North Central Division from 1989-1990 where he established an Urban Fishing Committee. And was President of AFS from 1994-1995.

He served two years as Associate Editor of the North American Journal of Fisheries Management.

One of his lasting legacies as President was to establish three new awards to recognize individuals, groups, agencies, or companies that advanced aquatic resource conservation at the national or international level.

He was rewarded by the American Fisheries Society for his time and efforts by many awards, including: an Award of Excellence, a Distinguished Service Award, a Meritorious Service Award, and the Fisheries Management Section's Award of Merit. And he was elected to the Fisheries Management Hall of Excellence in 2001.

In his circle of friends, employees and cohorts, he became known as “Mr. Fish Management.”

In Missouri, the local chapter of AFS renamed their one of their awards the “Lee Redmond Citizen’s Award,” which is given annually to persons who make substantial contributions to Missouri’s aquatic resources.

This “pat on the back” echoed Lee’s philosophy of freely dispensing wisdom and encouragement, and giving credit where credit is due. It’s a lasting message to all of us.

Lee was a good administrator with a couple of quirks. For instance, he was not an advocate of the clean desk group, but just like me, stacked his papers high. To the point that a visitor said to him, “Is this a recycling center?!”

Lee Redmond was: a good friend to us all; a gentle and kind person; a true, great, and successful conservation warrior; a good example for his employees of service, scientific rigor, and friendly, gentlemanly conduct; a leader in the field of fisheries management in Missouri, throughout the Midwest, and anywhere warm water fishes swim; and a leader in the American Fisheries Society.

And, on top of all that, he was a really fun person to be around.

Building on a successful innovative symposium at AFS Spokane, we are hosting another "Fisheries Biologist's Guide to Using Human Dimensions Data" and want you to be a part of it!

**Biological and Water Quality Assessment the Middle Scioto River, Lower Olentangy River, and Selected Olentangy Tributaries 2020: Including a 50 Year Retrospective Analysis of Available Biological and Water Quality Data. Franklin and Pickaway Counties, Ohio**

MBI announces the release of a major report on the historical ecological success story of Central Ohio's two major rivers. This report, entitled *Biological and Water Quality Assessment the Middle Scioto River, Lower Olentangy River, and Selected Olentangy Tributaries 2020: Including a 50 Year Retrospective Analysis of Available Biological and Water Quality Data. Franklin and Pickaway Counties, Ohio* (MBI Technical Report MBI 2022-4-6), is a major milestone in the management and assessment of rivers and streams as affected by 50 years of the implementation by the Clean Water Act (CWA) by private, local, state, and federal agencies and organizations. The scope of the report's 2020 biological and water quality assessment, included the Scioto River mainstem between Griggs Dam in Columbus to Canal Park in Circleville, the Olentangy River mainstem from Powell Rd. to the mouth in downtown Columbus, and three Olentangy River tributaries in Columbus, two of which are part of Project Blueprint.
