## Chapter News

### New York Chapter Awards

At this year's Annual Chapter Meeting we will be recognizing two individuals for their work related to fisheries/aquatic resources within New York.

The candidate for the Conservationist of the Year Award is Bill Wellman, Secretary of the Lake Champlain Chapter of Trout Unlimited. Bill has devoted much of his time working closely with NYSDEC regarding TU concerns and views on fisheries and environmental issues within New York. For example, he has played a critical role in responding to Didymo in NY. He has arranged for funding from several TU chapters, assisted the Ausable River Association with developing posters and rack cards and recruited volunteers to distribute posters and rack cards. In addition, Bill conducted two stream restoration projects on the Salmon River, helped garner public and political support for fish passage at the Imperial Dam and initiated the adopt a salmon program in several area schools.

We are also planning to bestow the first David Bryson Memorial Award to Matthew Bowker a senior at Cortland High School. Matt is very interested in fish and fisheries and is planning on attending Cobleskill next fall. He is also an Eagle Scout candidate; his Eagle project was focused on a popular fishing area in Homer, NY.

Remember it is never too late to nominate our peers for their outstanding work related to fisheries and aquatic resources. The New York Chapter has three award classifications for recognizing our fisheries professionals:

#### *Honorary Member Award*

The Honorary Member Award is for significant involvement and accomplishments by an individual to the Chapter or official position. Nominations should include a brief biography and discussion of the significant involvement and contributions towards conservation of fisheries/aquatic resources within the Chapter.

#### *Professional Achievement Award*

The Professional Achievement Award is awarded to an individual employed in a field related to fisheries and aquatic resources. Nominations for individuals should include a brief biography along with information pertaining to service, impact on the resource and other professional and significant accomplishments

#### *Conservationist of the Year Award*

The Conservationist of the Year Award is for significant involvement and accomplishments by an individual or group. Nominations should include a brief biography and discussion of the significant involvement and contributions towards conservation of fisheries/aquatic resources.

**2009 – 2010 Chapter President Candidates**

**Randy Jackson**

Sr. Research Associate, Cornell University

My interest in a career in the field of fish and wildlife management took root while I was still in grade school watching Marlin Perkins on Mutual of Omaha's Wild Kingdom, but my path to a fisheries specialty was not direct. After pursuing rather aimless courses of study as part of my B.S. at Montana State University and a Master of Agriculture at Texas A&M University, I landed in Oklahoma in 1985, where I worked on a privately operated wildlife demonstration facility, with deer management as the primary focus of my job. Two and a half years counting and dissecting deer revealed to me my deep interest in the fisheries side of the profession. I moved to North Carolina State University in 1987 to take a 4-year temporary position as a research technician in charge of a reservoir fisheries project. Thirteen years later, I was still at N.C. State. My research opportunities included largemouth bass recruitment dynamics, predator-prey interactions, striped bass habitat selection and sampling assessments. Enrollment in the employee degree program also resulted in my receiving a Ph.D. in 1999. I moved to New York in 2000 as a Senior Research Associate at the Cornell Biological Field Station on Oneida Lake. In New York, as in North Carolina, my research has been conducted in collaboration with state agency biologists, and my research includes recurring themes of attention to basic applied issues such as assessment of sampling techniques and assessment of management actions such as stocking. I joined the AFS in 1984 and have been active at a variety of levels, including 12 years on the Reservoir Committee of the Southern Division, President of the Fisheries History Section, and Northeastern Division representative to both the Fisheries Management and Education Sections. I believe that active participation in the AFS facilitates better communication among professionals working at various levels in the field to achieve shared goals and is also provides a critical environment for training those who will replace us in the next generation.

My path towards becoming a fisheries biologist began on the banks of Catskill streams absorbing fishing skills from my father, my first and greatest mentor. The passion he instilled in me for the outdoors and fishing led to a B.S in Fisheries from Humboldt State University in 1991. A few months later, my professional career began when I was hired by the NYSDEC as a fisheries biologist on Long Island. My job duties included designing and conducting freshwater fisheries surveys in lakes, ponds and streams; conducting creel surveys; and designing and implementing the Region 1 Fisheries educational program. I switched hats in 2003 when I became the Region 1 Habitat Manager where I oversaw the administration of the freshwater wetlands program on Long Island. My duties included conducting permit reviews, investigating Article 15 and 24 violations, and resolving those violations either by consent orders or legal referrals. I returned to the Bureau of Fisheries in 2005 when I became the Fisheries Outreach Coordinator for the New York DEC. I first attended a NY Chapter AFS meeting in 1993 and have been to most meetings since. During the 2006 AFS Meeting in Lake Placid, I was the AV Chair, Co-Website Chair, Program Guide Designer and just about any other role that was needed. I am currently the Northeastern Division AFS website coordinator and represent the NED on the AFS Electronic Services Advisory Board. I have assisted with AV at previous NY Chapter meetings and am Program Chair for the 2008 meeting of the NY Chapter of AFS.
