

October 20, 1965

The organizational meeting of the Professional Fisheries Association of New York was held at Holiday Inn, Rome, New York on October 13, 1965. John Gould acted as chairman--the meeting was called to order at 9:30 p.m. Introductory remarks made by Mr. Gould included a resumé concerning organization discussed at the February, 1964 meeting held at Cornell University; a presentation of the Constitution and By-laws for approval as prepared by the Messers. Gould, Griffiths, Neth, Pearce, Youngs, Harding and Ehlinger at Lake Colby on March 9-10, 1965; and a recommended list of officers as submitted by Robert Harding, Chairman pro tem of a nominating committee consisting of the Messers. Stiles, Webster, Wich and Kelly. Mr. Gould also announced that, pending the outcome of the meeting and the adoption of the Constitution and By-laws, dues would be accepted after adjournment.

A motion to accept the Constitution and By-laws as submitted was made by William Pearce. A raise of hands carried the motion.

As no nominations were proposed from the floor, the slate of officers as submitted by the nominating committee was approved. John Gould is president; Robert Griffiths, Vice-president; William Youngs, Secretary and Neil Ehlinger, Treasurer. Henry Regier and Erwin Alperin were named as directors. The office of Secretary is subject to acceptance by Mr. Youngs who was not in attendance.

Mr. Gould, in suggesting possible subject matter for a future meeting of the association, brought up the question of exploring salary grades. This touched off a lively discussion with many participating. It was concluded by deferring the matter to a regular meeting. A point interjected by Mr. Bentley and endorsed by Mr. Harding was emphatic in that the goals and objectives of the association should have primary consideration--other matters, secondary.

The importance of making known, publicly, aims and projects connected with fisheries work was stressed. The Conservationist and other news media were mentioned as possible outlets.

Robert Zillicou made a motion which was seconded and approved to (1) investigate all aspects of affiliation of the P.F.A.N.Y. with the American Fisheries Society and (2) explore the possibility of one meeting a year with the Wildlife Society.

Mr. Gould, in reply to a query, reported that a program committee had already been set up to cover the next scheduled meeting of the P.F.A.N.Y. This meeting will presumably be held at Cornell University sometime during February, 1966.

The meeting was adjourned at 10:30 p.m.

1965 March - Fishery COOP Workshop at Cornell - Subject "Age and Growth of Fish." On March 10, 1965 at this meeting John Gould suggested creation of the N.Y. Association of Fishery Biologists.

October - Rome, N.Y. meeting of N.Y. Conservation Department Bureau of Fish - Organizational meeting of Professional Fisheries Association of New York - (Initially N.Y. Association of Fishery Biologists.)

1966 March - First meeting of the "Professional Fisheries Association of N.Y. (PFANY) - Met in conjunction with the Fishery COOP Workshop at Cornell - Subject "Statistics". President - John Gould - Membership - 68.

At the meeting the members present agreed nearly unanimously that the advantages inherent in our fisheries group - i.e., the unique opportunities for really productive, searching discussion of fisheries research and management topics of mutual interest by all fisheries workers of the State - would be greatly reduced by changing over to a "joint meeting" arrangement with Wildlife Chapter. (Taken from the records of 1966.)

1972 January - Joint meeting with Wildlife Chapter - "How Does Fish and Wildlife Fit into the New N.Y. Dept. of Environmental Conservation." President - Howard Loeb. Membership - 91.

First Chapter News Letter - Ned Holmes Editor. Last year of N.Y. Fish News (Dept. publication). Work still progressing on film "The Aquatic Ecologist".

1973 February - Seventh annual joint meeting with the Wildlife Chapter - Theme - "Fish and Wildlife Values, Conflict or Concord". President - Martin Pfeiffer. Membership - 97.

For the first time $\frac{1}{2}$ day was devoted to separate sessions. Fisheries subject was "Fish Management Today - Where Do We Go from Here". Film "The Aquatic Ecologist" nearing completion.

1974 January - Eighth annual joint meeting with the Wildlife Chapter - Theme - "Fish & Wildlife in Regional Planning: The Adirondacks and Beyond". President - Bill Pearce. Membership - 74.

Separate Fisheries Session Saturday morning "Role of Forage Fish in Salmonid Management". This was an excellent session with speakers such as N. V. Martin from Ontario. A real bright spot compared to most joint sessions.

Film - "The Aquatic Ecologist" was finally completed. Dave Haselman and Bernie Holtman who produced the film did an excellent job and covered over 10,000 miles gathering material. The College of Forestry at Syracuse contributed the services of Dave and Bernie and the N.Y. Chapter begged, borrowed and pleaded (plus sold some film) to come up with the \$11,500 needed by the end of 1974. Steve Simkins was Committee Chairman through to the end with Dwight Webster and Bill Flick committee members attending all meetings for 6 years. Bob Werner was the super salesman that handled film distribution following completion and collected sale money to get us out of debt.

1975 February - Ninth (and last) joint meeting with the Wildlife Chapter. Also involved in this meeting were The Soil Conservation Service, and the N.Y. Upstate Chapter of the American Institute of Planners. Theme - "Environmental Aspects in Land Use - Preservation vs. Development". President - Bill Pearce. Membership - 84.

There was very little interest in this meeting (no separate session for fisheries) and total attendance was 24 with 28 needed for a quorum. Officers from the previous year were asked to continue serving.

Film - "The Aquatic Ecologist" received an award for reaching the finals in the American Film Festival. It was also accepted for entry in the "Cine Film Festival". It was selected by the United States Information Agency for use in their Science Reports. A short made from the film was made into 22 languages and sent to 84 countries.

Re: Proposed changes in job title structure Conservation Biologist, Aquatic Biologist, Wildlife Biologist, Fish Pathologist, Wildlife Pathologist.

Considerable study has been made of the Conservation Biologist situation and related problems. This began as a suggestion from Personnel that the course requirements for Conservation Biologist be revised and this matter was first referred to Joe Dell and to me. However, once we got into this, we found it is not a simple problem of improving qualifications of this one title.

Under title of Conservation Biologist, work assignments are extremely varied. For example they may include specialized duties either in research or management fields in such lines as acquisitions, B.J. or P.K. projects, nutrition, pathology, etc.

The professional qualifications for Conservation Biologist are not high. Seniors about to graduate are eligible for the Professional Career examination from which the list is made up.

There may be a continued need for keeping the title and qualifications of Conservation Biologist. This depends on anticipated work assignments. However, many assignments are professionally rather specialized and when a vacancy occurs in a specialized job, it is difficult to fill it satisfactorily from the Conservation Biologist list.

This is one reason we are proposing changes in other job structures. If we could recruit directly into title of Aquatic Biologist, Wildlife Biologist, Fish Pathologist or Wildlife Pathologist, assuming higher qualifications and a subject matter examination are required, we think this would greatly improve the outlook.

There are other good reasons. Promoting from Conservation Biologist to Senior Aquatic Biologist, Senior Wildlife Biologist or Senior Fish Pathologist as has been the custom has other disadvantages. It cuts out direct recruitment from the ranks of specialized graduate students who have not served as Conservation Biologist. It would be interesting to know how many trained men including some with PhD, MS or equivalent in graduate school specialization have by-passed any consideration of New York jobs at the grade I4 level.

Other states seem to be recruiting directly for specialized jobs. In New York this was formerly done. All is all, it is known that such practise is workable.

Another reason for change is the long overdue promotion of a considerable number of our Conservation Biologists who have long demonstrated competence in specialized, professional work. There is no job title at present that fills the bill. There would be little hope of getting approval to upgrade them to Senior Titles (SG18).

There is no recognized base job title in many lines in which there is a Senior Title. This is an unusual situation as Civil Service has bottom rungs in most of their job structures. The use of a general title of Conservation Biologist from which to move to Senior Aquatic Biologist, Senior Wildlife Biologist, etc. is unusual.

In brief what we would like to get your opinion on is a plan to:

- (1) Keep Conservation Biologist (GS 14) for filling unspecialized assignments. These might include acquisitions, unspecialized work assignments in fish or wildlife (also including some jobs working in both fields).
- (2) Get approval to set up grade 16 titles of Aquatic Biologist, Wildlife Biologist, Fish Pathologist and Wildlife Pathologist. These jobs should require graduation, graduate school or work experience (or satisfactory combination). An examination in the field of specialization should also be required.

These changes sound rather simple. Actually, there are some formidable difficulties. I think it will take a strong and united presentation to get such changes. Each of you is in a way the "consumer" of the products of Civil Service. If you are not satisfied with the current situation and are willing to express your opinions, I believe a strong presentation can be put together. If thereafter, a study is made by Civil Service we know from experience this takes time. Therefore the sooner we get the ball rolling the better.

We can anticipate some snags in getting a wide-scale review of the many Conservation Biologists we think should be upgraded to one of the new grade 16 titles proposed. Then after exam is given, we may find some of the best men may not stand high enough on the list. This problem will require consideration. It is to be hoped that a plan can be worked out both for upgrading and for filling new vacancies at a more specialized professional level.

This matter has been discussed with quite a few of you from time to time but it seems desirable to get your opinions in detail. Dr. Chestum has suggested that I round up this information.

In your reply please include answers to these questions:

- (1) In your region or project, how many Conservation Biologists (include vacancies) do you have?
- (2) How many of these regularly have duties concerning both Fish and Wildlife?
- (3) How many are performing work that you consider merits a higher grade and what title or titles would you propose for such promotion?
- (4) In the case of vacancies, how many Conservation Biologist openings would you prefer to fill at that title?
- (5) How many would you prefer to fill at other titles? (Give suggested titles).

If possible please reply within ten days.


Woody Seaman has passed your letter to him on to me. While no reply on my part seems necessary, I feel compelled to comment on the imminence of your establishment of a New York chapter of the American Fisheries Society.

I see by a notation on your letter that Mrs. Frye has sent literature which may be of assistance to you in establishing guidelines and by-laws. I feel extremely proud of the fact that I have been called the father of the local chapter movement in the American Fisheries Society, because I believe that this development will shortly be the backbone of our organization. Wherever these have been established, they have been met with great enthusiasm on the part of the members in the area. Invariably they have also met an influx of new members. Our membership chairman in the state of Oregon estimated that our membership has more than doubled since the establishment of the state chapter here.

This is not the important aspect, however. Paramount is the fact that we are providing a better service to our members in a local, informal nature where people at the field level can find it economical to attend even if they have to do so at their own expense; something they could seldom do in the case of national or regional meetings. From our experience thus far, the most successful application of the local chapter is that involving an annual meeting at a well-known university or college, bringing in the student members wherever possible, although it does not necessarily have to be so.

Congratulations on your effort in this respect. I sincerely hope that you will have every success in the formation of this group. I know that once it is formed, you will find it popular.


