    - i. Steve Malloch represents a public charity, Resources Legacy Fund that has a \$50M 10 year dam removal and river restoration program (<a href="https://resourceslegacyfund.org/our-approach/open-rivers-fund/">https://resourceslegacyfund.org/our-approach/open-rivers-fund/</a>). He is looking to BES to develop a nature-like fishway guidance document (or workshop/short course).
    - ii. A comprehensive nature-like fishway document could include design guidance, planning, siting, when and when not to do it, modeling tools, interpreting results, case studies, lessons learned, implementation, costs, etc.
    - iii. There was an effort in 2010 to do a living database of projects and they have information on over 400 nature-like fishways (Laura Wildman)
