Letter to the Membership

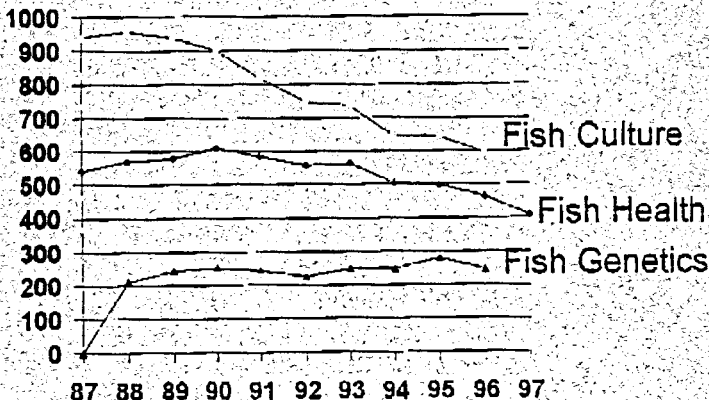
Dear Fish Health Section Members,

I want to present a report to you on the state of the Fish Health Section of the American Fisheries Society and, as I finish my term of office, my hopes for this wonderful organization. Our membership stood at 461 in 1996 and now stands at 409 in 1997. In fact, membership has been declining steadily since 1990 (see figure). The reasons for this decline are not clear but it appears to coincide with a policy change in the American Fisheries Society to advocate environmental issues. We, as an organization of professionals in fish health, must begin to consider what effect these issues will have on our future. It is a very important consideration if we are to keep our commitments to increase our membership and provide responsible leadership. These figures have direct bearing on the publication of our society's primary scientific publication, *Journal of Aquatic Animal Health*, and on the effectiveness of our collective voice in establishing procedures for the diagnosis,

certification, and treatment of fish and eggs for transport in the United States. For two years, the FHS-By-laws Review Committee under the leadership of Ron Thune and Ted Meyers has been working to develop a new set of Bylaws and a Procedure's Manual to change our committee structure, provide for an affiliate membership category, and add the office of Vice President. On August 23, 1997, the Governing Board of the American Fisheries Society voted at its annual meeting in Monterey, California to accept these changes. We may now proceed officially to change the committee structure, hold elections for the new positions created by these changes, and decide how to recruit our new affiliate members. I have worked with the Scott LaPatra (President) and the Executive Committee to make the following appointments for 1997-98. These appointments were made to assist the section in the transition from the old committee structure to the new one since approval for the Bylaws changes did not occur until August 23, 1997. Elections should be held for the following offices: position of Vice President, one position on the Professional Standards Committee for 3 years, three positions on the Technical Standards Committee for 1, 2, and 3 years respectively, and a position on the Nominating Committee for 3 years. I have asked the Nominations Committee to seek candidates for these positions. A ballot for the elections should be arriving soon. In the past year, issues regarding the relationship between Fish Health Professionals and Veterinarians have continued to be of great concern for the Section. Scott LaPatra (President Elect) and Jim Winton (Past President) have taken the lead in working with the American Association of Veterinary Laboratory Diagnosticians (AAVLD), the U.S. Animal Health Association (USAHA), American Veterinary Medical Association Aquaculture and Seafood Advisory Committee (AVMA - ASAC) and the USDA Animal and Plant Health Inspection Service (APHIS) in developing a coordinated National Aquatic Animal Health Strategy. Scott has represented the Section at several meetings of the USAHA/AAVLD/ AVMA-ASAC and now belongs to both the USAHA and the AAVLD committees on Aquaculture. The committee on Aquaculture for the AAVLD is chaired by Jerry Heidel who states that the committee is "interested in all aspects of diagnostics as it relates to aquaculture."

The other issue that has generated a great deal of discussion by members of the Section is the use of advanced technologies in fish health management. We must begin to develop procedures for validating these technologies and decision making guidelines for the results of different diagnostic procedures. Joe Marcino, Department of Natural Resources, Minnesota, has agreed to chair an Ad Hoc Committee of the Fish Health Section on this issue. This committee will present the draft of a set of recommendations on the use of advanced technologies for the Technical Standards Committee at the next national meeting in Baltimore, Maryland. The Fish Health Section has met a number of challenges this year with some success. Our Bylaws were passed and we will be able to recruit affiliate members now. The Governing Board of the AFS applauded our decision to hold the 1999 national meeting of the FHS with the national meeting in Charlotte, North Carolina. Bob Carline will be President of AFS at this session and he wants to work with us to strengthen our ties with the parent society. Christine Moffitt will be President of AFS in 2000 when the national meeting will be held in St. Louis, Missouri. Chris has asked us to consider holding our national meeting together with the AFS national meeting for that year as well. This past year has been a great learning year for me. I now understand the wisdom of the change in Bylaws calling for a Vice President's office. Just when you begin to understand the responsibilities of the office and make the appropriate contacts for the Section, the President's term of office ends. I want to thank Jerri Bartholomew, Secretary/Treasurer, for her invaluable help and Scott LaPatra for his tremendous enthusiasm and efforts to create liaisons with other organizations concerned with aquatic animal health. I leave the FHS in very capable hands.

2. Type abstract in Word Perfect format using a Courier 10 font. Denote genus and species with italic script.
3. Capitalize only the first letter of each word in the title.
4. Provide a double-space between the title and authors; a single-space between the authors and their affiliations; and a double-space between the affiliations and main body of the abstract.
5. Underline the name of the author who will give the oral presentation and use numeric superscripts for affiliations.

ERRATUM

I would like to apologize for an error we have made with reference to a virus observed in koi in California. In the last issue of the American Fisheries Society Fish Health Section **Newsletter 25(3)1-2** we stated "to the best of our knowledge the first observation of a true poxvirus from fish". Our knowledge was not very complete. We have since discovered that this virus and the condition it causes had been observed in fancy carp in Niigata Prefecture, Japan since 1984 (Ono et al., *Fish Pathology* 21(3)167-175, 1986). We had missed this important earlier work by Professor Ono. Subsequent to our newsletter submission a report was published by Oyamatsu et al. 1997 (*Fish Pathology* 32(3) 81-88) that further describes properties of the agent and disease it causes. The virus is referred to as carp edema virus (CEV). I apologize to my Japanese colleagues for my oversight in failing to properly acknowledge their work. We are currently with Professor Fukuda, Laboratory of Aquatic Pathology, Tokyo University of Fisheries in better characterizing the agent we have found here in North America.

FHS PARTICIPATION IN THE AVMA ASAC MEETING

During the Fish Health Section (FHS) annual meeting in Madison, WI last year, the membership voted unanimously to support an active role of the FHS on issues of importance to the Section. One of those issues was for the American Fisheries Society FHS to cofacilitate with the American Veterinary Medical Association (AVMA) further work towards development of a National Aquatic Animal Health Strategy Plan. The FHS met with the AVMA Aquaculture and Seafood Advisory Committee (ASAC) at their most recent meeting which occurred in conjunction with the World Aquaculture Society meeting in Seattle. This committee is an advisory committee to the executive board of the AVMA on issues regarding aquaculture. During our meeting I explained to the committee about who, what, where, when and why the FHS exists. I also explained our work with the American Association of Veterinary Laboratory Diagnosticians and laboratory accreditation procedures and the United States Animal Health Association resolution that had passed (FHS Newsletter 25 (1): 1-2). I also stressed the change in our Bylaws regarding affiliate membership and how the FHS was interested in veterinarians becoming more involved with the section and taking advantage of our already established programs and expertise. This was well received and we agreed to write a joint letter to the Departments of the Interior, Commerce and Agriculture requesting their cooperation in development of a National Aquatic Animal Health Strategy Plan.

Nominations were recently opened for several positions on the AVMA ASAC whose term had expired including a representative from the aquaculture industry that was a non-DVM. Due to the efforts of Ray Brunson and Drs. Joy Evered and Phil Mamer, I was nominated and appointed to the AVMA ASAC. In this capacity I will strive to keep the Section updated on the Committee activities and continue to foster a collaborative relationship between the FHS and the AVMA ASAC.
