Dear Fellow AFS-FHS Members,

As the AFS-FHS President for the 2020-2021 term, I would like to begin by thanking you for the opportunity to serve you and our professional organization, which not only has a history of outstanding excellence, but also one of taking initiative and leading, as evidenced by being the first section within the AFS ever formed (out of >20 that now exist). This is just one of several facts I recently learned as I continue to review the newsletters from the inception of the AFS-FHS in 1972 to present. The contributions that have been and continue to be made by FHS members are striking, and I believe now maybe more than ever, such contributions will be even more imperative. But before I delve into the efforts that I plan to pursue, I would like to thank and congratulate several individuals.

First, thank you to my good friend and colleague, Dr. Ben LaFrentz, for his outstanding dedication and tireless efforts as the AFS-FHS President and AFS Governing Board member last year. You will notice there are a few seats I am still in the process of filling and once complete, this list will be posted to the FHS website. To help broadcast the efforts of the AFS-FHS, I will also be appointing an additional "social media" savvy member to the Section Communications Committee to not only help with our currently existing Facebook page (which was suggested by the Sections Committee last year), but also to establish additional social media outlets (e.g., Twitter) to help widen our communication efforts and further increase the visibility of our section.

Before turning to my focus for the upcoming term, I would like to acknowledge how challenging much of this past year has been for all of us, but some far more than others. COVID-19 has taken lives, derailed our economy, disrupted our research and education plans, set our normal way of life into disarray, as well as exacerbated and further exposed the social injustices that continue to plague humanity. And yet from this

As many of you are aware, the AFS, in collaboration with the FHS, recently received a grant from the Multistate Conservation Grant program to support revising and updating the Blue Book. Although COVID-19 delayed the process, this effort is set to begin in earnest at the outset of 2021. Between now and then, a project manager will be hired using the funds from this grant and, in collaboration with a steering committee that will be appointed and comprised of state, federal, tribal, and private stakeholders, the direly needed Blue Book revision process will begin. Importantly, these efforts will be guided by the recommendations of the ad hoc committee that were circulated to the membership for review and comment this past March. I am extremely excited about the momentum my predecessors gave this initiative, and I will be placing heavy emphasis on elevating the productivity of this endeavor throughout my term even further. However, given the extent of revisions that are needed, I do not believe this is a "1-year job." To that end, I will be striving to form a consortium with entities interested in sustaining efforts to keep the Blue Book in a contemporary state for years to come and intend to utilize this partnership to competitively pursue extramural funds to help do so.

While emphasizing efforts to update the Blue Book, I also intend to work closely with the various AFS-FHS ad hoc and standing committees, as they too will not only be crucial for this process, but also for their annual duties. To do so, I will follow the model that Past President Guppy Blair devised and that Ben LaFrentz also utilized: in short order, I will be contacting all Committee Chairs and request that they, in concert with each respective committees' members, devise goals to be tackled and seen to fruition this year.

Last but definitely not least, I will be establishing an ad hoc Strategic Planning Committee, as I believe having short, medium, and longer-term visions for the AFS-FHS is crucial. To do so, I will be reaching out to various individuals to help with this endeavor. Please stay tuned.

In closing and to quote the first President of our section, Dr. John Fryer, "The future of the FHS lies in the members, individually and collectively." I could not agree more! Thank you for the privilege of serving as the AFS-FHS President, and I am excited to work shoulder to shoulder with you all over the next year.
