PRESIDENT'S MESSAGE

In 2005 our agency was fundraising for a major river restoration project. While we had gained widespread support, one holdout remained. An important funding partner was apprehensive over proposed changes to the river. It seemed impossible to gain their approval. Eloquent monologues, fancy graphs or glittery PowerPoint slides could not ease their concern. "Why can't they get it?" I often lamented to my colleagues. After all, we had spent countless hours surveying, modeling, drafting, editing and redrafting plans.

As critical deadlines drew near I again met with a representative of the group. The conversation rapidly eroded into explicit instruction on where I could place "all of my fancy book learnin' and models." A colleague who witnessed the exchange approached me afterwards. He said, "I think I finally recognize the problem. They genuinely don't understand what you're telling them. We need an artist's rendition of the project." Two months later our team unveiled an artist's rendering of the project during the group's annual fundraiser. A gruff voice spoke up and I braced myself for impact "You should have told us it would look like this! If you guys will build that we'll write you a check tonight!"

We had not changed the content of our message but had finally spoken the audience's language. After a decade of mentors and constituents telling me to "keep it simple" and "speak English" I am beginning to understand. Research, data and analysis convicts and directs us in making sound environmental decisions. Technical methodologies and jargon have a place therein. However, we are rendered ineffective when our delivery styles intimidate or frustrate the audience.

Controversial issues abound, from the depletion of aquifers to unpopular fisheries management decisions. Good science alone may not influence outcomes. People will. I encourage you to educate your stakeholders in a practical manner.

Lastly, I am grateful for all who attended the 2010 Oklahoma and Arkansas joint chapter meeting in Fort Smith, AR. I am especially appreciative of those who lent a helping hand. Over eighty Oklahoma fisheries professionals and students were in attendance!

I have also heard from a couple of people that there might be interest in a workshop on electrofishing theory, with a possible "lab" type component for calibrating electrofishing boats to better standardize effectiveness and facilitate CPUE comparison among districts, labs, etc. I would welcome feedback on this idea. Specifically, would it be worth having a workshop outside of the annual meeting (i.e., sometime during a spring season when the weather is not too cold) to be able to bring electrofishing boats for oscilloscope measurements to calibrate power output, or would you prefer to just cover the theory at an annual meeting with no field calibration (but I could cover the procedure in the theory section). 


