#### PRESIDENT'S MESSAGE

During the last couple of years as President-elect, and now as President, I've become increasingly aware of the politics that we as fisheries scientists and managers more commonly call fisheries biology. I've known for years that managing fish is more about managing people than fish, but that concept has never been more apparent than now. The issues of selling water to other states, application of chicken litter and the impact to our waters, tribal rights to waters, a summer of recordhigh temperatures and peak power demands of hydropower and their effect on downstream fisheries, and the "blame game" that is the relationship between Southwest Power and the Corps of Engineers, just to name a few of the issues that we as fishery biologists deal with daily to try to better manage our fisheries populations and represent our constituents. Reaching management goals and objectives often requires that we spend substantial time developing good relationships with all our constituents and less time on the water. This strategy is not one that I was excited to learn existed. In my early years with the Oklahoma Department of Wildlife Conservation, I enjoyed working on the lake conducting various sampling techniques and enjoying every minute of it. Well, okay, most every minute of it with the exception of gillnetting in the winter with frozen nets and ice covering everything in the boat. My predecessor even loved that part. He used to say, "Now this is gill nettin' weather." I don't think he would have enjoyed what has now become an essential part of

fisheries management--politics. ODWC negotiates daily for water releases to maintain the trout fishery below Tenkiller Reservoir. No water has ever been allocated to maintain the federally mandated mitigation of trout stocking in the lower Illinois River. Developing relationships and contacts remains an integral part of securing water for this stream. I suspect most biologists have similar struggles. I was recently asked at a presentation to a civic group what is the biggest challenge I face as a fisheries biologist. I told the group it had to be water. The lack of water and the degradation of water quality will be my greatest challenge as a biologist. Securing access to water is and will continue to be, a political struggle. Since I personally have no water rights, I will have to rely on others to provide my lakes and streams with both quantity and quality of water to support the fisheries that I have been charged with managing. The political component of fishery management is not one that I particularly enjoy but it is one that all biologists must learn to accept and even embrace to help manage our waters to their greatest potential. The upcoming Oklahoma Chapter of the American Fisheries Society meeting in February is an opportunity for students and professionals alike to begin to develop relationships with various agency contacts. Developing these contacts could be the most important step towards fishery management you may ever make. I hope everyone will make attending the upcoming meeting a priority and I would like to thank each of you that attended our snow-delayed meeting last year. Anyone who has ever served or will serve as an officer deserves our gratitude. Thanks to all who have made my job easier.

#### **Continuing Education** – Dan Shoup

This year's annual meeting will include a workshop on common issues in fish disease and fish health. It will cover issues from the prospective of both hatchery work and natural populations in the field. The workshop is being led by two faculty members from the OSU Veterinary Medicine College that specialize in Zoo and wild animal medicine.

I would also be interesting in receiving input on a possible electrofishing workshop to be held sometime in the future. This could include a lecture series on electrofishing theory, including recently published information about the proper way to standardize power applied to the fish (so CPUE is comparable when fishing in systems with different water conductivity). We could also include a "lab" component where participants could bring their boat to have measurements taken to calibrate a standard output table. If there is sufficient interest in this, we might consider doing this some spring/summer when the weather is nice enough to be outside for the lab portion. Please provide feedback so I can gauge the potential interest in this topic.




