### "Department Mourns Environmental Pioneer"

"Jimmie Pigg, a former member of the Oklahoma Department of Wildlife Conservation's Wildlife Diversity Technical Committee, died of a heart attack February 24 in Memphis, Tenn."

"An ichthyologist for the Oklahoma Department of Environmental Quality, Pigg was traveling to a business meeting at the time of his death."

"Born and educated in Bartlesville, Pigg earned a Bachelor of Science Degree in biology and health and physical education in 1953 from Oklahoma A&M. He completed his Master of Science Degree in Natural Sciences from Oklahoma A&M in 1962."


"He began his career in Oklahoma government in 1974 as a part-time research biologist. During his tenure as an ichthyologist with the Oklahoma Department of Environmental Quality, he worked as the biomonitoring director and senior environmental specialist."

"Among his many awards, Pigg was named Oklahoma Conservationist of the Year by the Oklahoma Wildlife Federation in 1974 and 1996. In 1983, he received the Presidential Award of Excellence in Science and Mathematics Teaching from President Ronald Reagan. This award meant the most to him because his students nominated him for it."

# OKLAHOMA CHAPTER AMERICAN FISHERIES SOCIETY RESOLUTION

- WHEREAS, on October 8, 1998, companion bills were introduced in the U.S. House of Representatives (H.R. 4717 The Conservation and Reinvestment Act of 1998) and Senate (S.2566 The Reinvestment and Environmental Restoration Act of 1998): and on January 19, 1999, the Senate reintroduced S.25 The Conservation and Reinvestment Act; and
- WHEREAS, both bills in their Title III sections dedicate a percentage (10% in H.R. 4717 or 7% in S.25) of federal offshore oil and gas revenues to state fish and wildlife agency programs and related recreation and education; and
- WHEREAS, the Oklahoma Chapter of the American Fisheries Society promotes scientific research and enlightened management of aquatic resources for optimum use and enjoyment by the public; and also encourages comprehensive education of fisheries scientists and continuing on-the-job training; and
- WHEREAS, with year 2000 oil and gas revenues estimates of \$4.59 billion, the Oklahoma Department of Wildlife Conservation could receive additional federal revenues equal to or greater than current combined PR and DJ/WB income for a comprehensive wildlife program, and especially for nongame fish and wildlife, allowing the development of proactive, fully responsive programs to prevent additional listing of aquatic species, and to protect water quality, and to conserve the broad range of game and nongame species; and
- WHEREAS, both bills were introduced in Congress with bipartisan sponsorship and with the support of more than 3,000 conservation organizations and related businesses, including this organization;
- NOW, THEREFORE BE IT RESOLVED by the Oklahoma Chapter of the American Fisheries Society meeting on February 3, 1999, that the Oklahoma Congressional Delegation is urged to support passage of these bills, and the Wildlife Conservation Commission is urged to work diligently to ensure these bills' passage in Congress.

The above resolution was drafted after being approved by the members present at the 1999 business meeting of the Oklahoma Chapter American Fisheries Society at Roman Nose State Park, Oklahoma. It is provided above to provide discussion among those members who were not present but would like to have their voices heard. # Oklahoma Chapter of the American Fisheries Society 1999 Annual Business Meeting Roman Nose State Park February 5, 1999

The meeting was called to order at 8:01 a.m. **Julia Matlock** welcomed the 23 members in attendance.

#### 1. Treasurer's Report - Bill Wentroth

A 1998 financial summary was presented showing Income vs. Expenses for the year. Overall, there was a \$1,886.00 surplus last year. Investment funds yielded 4.2% in 1998 compared to 6.4% in 1997.

A brief discussion concerning the chapter membership followed. The decreasing membership trend was addressed and possible solutions were entertained.

#### 2. Environmental Concerns - Bill Wentroth

From a communication from **Brian Bristow**: Brian reported little action from the committee. He expressed a desire to be replaced by someone that is more involved with environmental issues. He felt like the "lag time" that is produced from the time he first sees an issue to the time that action is taken is counterproductive for the Chapter. Nominations were taken from the floor with **Jimmie Pigg** being elected as the new chairman.

A resolution concerning the Reinvestment Act was read and the wording discussed. A motion was made to support the passage of the Conservation and Reinvestment Act of 1998 and the Reinvestment and Environmental Restoration Act of 1998 if the wording was changed in paragraph 4 line 5 and 6 reading: "allowing the development of *conservation* programs to prevent additional listing of aquatic species". The motion was seconded and passed unanimously. It was agreed to put the resolution in the March Newsletter to receive additional comments for a 30 day period and evaluate the responses to determine the chapter's position statement.

#### 3. Newsletter Committee - Jim Long (OSU)

The Student Chapter has permanently taken over the newsletter responsibility for the Oklahoma Chapter. Ken Cunningham received appreciation for his hard work in previous years as Newsletter editor. There was discussion on who should receive the newsletter. The decision was made to send newsletters to all current chapter members, parent society members, and all large installations in the state with fisheries professionals.

#### 4. Activities Committee - Keith Thomas

The "White Elephant" Gift Exchange at the banquet went over well and will surface again at the next annual meeting. Keith resigned and **Barry Bolton** jubilantly excepted the chairman's position and is excited about the Y2K events of the future! It was asked that the EXCOM recommend what kind of emphasis on outreach the Activities Committee pursues in the future.

#### 5. Nominations - Kim Erickson

Kim presented a plaque from the Southern Division of the American Fisheries Society for *The Outstanding Chapter Award in 1998* to the President.

There were no nominees for the Outstanding Fisheries Worker of the Year.

The Jimmie Pigg Student Travel Scholarship winner for 1998 was **Keith Gido** from The University of Oklahoma for his fisheries research on Lake Texoma. Keith will be using this award for travel to the AFS Southern Division Mid-Year meeting. Congratulations Keith!

President Elect nominations were announced with **Paul Balkenbush** having no opposition. Paul was elected by proclamation. **Bill Wentroth** was elected to another 2-year term as Secretary/Treasurer for the chapter.

#### **BUSINESS OLD**

The chapter's Pond Management Coordinator position was never filled. Bill Wentroth nominated **Glen Gebhart** to the position. Glen was elected from the floor, unanimously.

#### **NEW BUSINESS**

A proposal was received concerning the protocol for handling resolutions, as a chapter. It was decided that the EXCOM should review and modify the protocol if needed.

**AFS** will join the Council of Aquatic Sciences (CAS) effective this year. The council consists of nonprofit scientific and professional organizations interested in exchanging information across disciplinary boundaries for purposes of marshalling science in support of public aquatic policy. The Society had participated in the formation of this group under Past-president Chuck Coutant's leadership, but we did not become a dues-paying member in part because the group seemed inactive. AFS member Mike Falter attended CAS's annual meeting in Banff, Alberta, last November and found the council alive, well, and planning a joint conference of member societies for 2004. 

The population of introduced Chinese mitten crabs has exploded in California, writes Lloyd Hess; the species has spread from San Francisco Bay up both the Sacramento and San Joaquin rivers. This catadromous crab rears in freshwater and returns to estuaries for spawning. The estimated number of mitten crabs passing downstream at the Bureau of Reclamation's Tracy Fish Salvage Facility (alone) grew from 50 in 1996 to 30,000 in 1997 to 1 million in 1998. **Licensed anglers decline.** In late September 1998, the U.S. Fish and Wildlife Service released figures indicating the number of fishing licenses sold nationally declined from 29.9 million in 1996 to 29.3 million in 1997. However, the expenditures for these licenses and permits rose from \$447 million in 1996 to \$498.4 million in 1997. (U.S. Fish and Wildlife Service Release)

Gulf Coast Fish Kill. On Sept. 23, 1998, TX Parks and Wildlife Dept. biologists conducted aerial surveys in response to an extensive mortality event involving hundreds of crabs, shrimp, redfish, trout, flounder, and other species along the Texas coast from Galveston to Beaumont and eastward to Louisianna's Atchafalya and Mississippi river basins. This event was blamed on a sudden influx of low oxygen waters flushed from coastal marshes into bayous and bays by extensive rainfall. (Fort Worth Star-Telegram)
