BYLAW AMMENDMENTS

As you all are aware, Past-President of the AFS Student Subunit Dan Dauwalter, and Bill Fisher, Student Subunit Advisor, have been working to amend both the OK-AFS Chapter bylaws and the bylaws for the OSU-AFS Student Subunit. These bylaw changes have been approved by the AFS Constitutional Consultant and the Chapter ECOM, but still need to be voted on for approval by society members so they can be sent to the Parent Society EXCOM for approval at the annual meeting in September 2006. A short explanation of the amendments is as follows:

The Oklahoma Chapter of the American Fisheries Society (OK-AFS) bylaws was originally approved in 1991. Since then, there have been several changes to the Society's Constitution, as well as the formation of Oklahoma State University Student Subunit in 1996. Therefore, the OK-AFS bylaws are in need of revision to incorporate these changes and recognize the Student Subunit. The major changes in this revision of the OK-AFS bylaws include: clarification of membership rights, recognition of the Student Subunit, and explanation of procedures for bylaw amendments.

Below are the OK-AFS Chapter and OSU-AFS Student Subunit Bylaws and the changes within. Bold face items are additions, and struck through items are deletions. Please read through *all* of the amendments and cast your vote whether you approve or not. Thank You!

BYLAWS

Oklahoma Chapter of the American Fisheries Society

Section 1 - Name and Objectives

The name of this organization shall be the Oklahoma Chapter of the **Southern Division** of the American Fisheries Society, and herein after referred to as the Chapter, **Division and Society respectively.**

The objectives of the Chapter shall be those of the American Fisheries-Society as set forth in Article I of the Constitution, and to encourage the exchange of information by members of the Society residing within the State of Oklahoma.

Section 2 - Membership

Official membership of the Chapter shall be composed of those American Fisheries Society members in good standing residing in Oklahoma. Only active members of the Chapter and Society may hold an office, chair a committee, or vote on Chapter affairs. Non-members of the American Fisheries Society interested in fishes, fisheries, and all other phases of fishery science and practice are encouraged to attend and participate in Chapter activities.

Members of the Oklahoma State University (OSU) Student Subunit shall be recognized as Chapter members.

Section 3 - Meetings

The Chapter shall hold at least one meeting annually at a time and place designated by the Executive Committee. The program and presentation of papers shall be the responsibility of the Program Committee.

Section 4 - Officers

a. The officers of the Chapter shall consist of a President, President-eElect, **Past-President**, and a Secretary-Treasurer.

b. All officers must be members in good standing of the Chapter.

- b. Officers shall be elected at the annual meeting. The Secretary-Treasurer may hold office for a period longer than one year, but the term of the other officers shall be one year. In case of a vacated position, the Executive Committee shall appoint a qualified replacement to fill an unexpired term.
- c. The term of office for all elected officers shall terminate immediately following the election and installation of new officers at the annual meeting.
- d. In the event of a cancellation of an annual meeting, the officers and the members of any committees shall continue to serve until the next scheduled meeting.

Section 5 - Duties of Officers

The President of the Chapter shall preside at all meetings, shall serve as the Chairman of the Executive Committee, shall represent the Chapter to the Southern Division and to the American Fisheries Society, and shall make such appointments and perform other duties and functions as are authorized and necessary, and proceed to the office of Past-President at the end of the term.

The President-eElect shall be Chairman of the Program Committee and shall assume the duties of the President in the event of his inability to act.

The Secretary-Treasurer shall keep the official records of the Chapter, collect and be custodian of registration fees collected under Section 108 of these Bylaws, and any funds which may be allotted to the Chapter. He The Secretary-Treasurer must submit a report on minutes of meetings to the Executive Secretary-Director and to the Secretary-Treasurer of the Division within 30 days after the annual Chapter meeting is held. The Secretary-Treasurer shall disburse funds as may be authorized and necessary, and shall submit a record of receipts and disbursements at the annual Chapter meeting. He The Secretary-Treasurer shall perform such duties as may be requested by the Secretary-Treasurer of American Fisheries Society and of the Southern Division.

The immediate Past President shall serve on the Executive Committee and assist other officers as needed.

Section 6 - Executive Committee

The Executive Committee of the Chapter shall consist of the elected officers, and the immediate Past President, and the President of the OSU Student Subunit. The committee is authorized to act for the Chapter between meetings and to perform appropriate duties and functions.

Section 7 - Chapter Committees

Committees and the Chairsman of Committees except as listed in Section 5 of these Bylaws, may be appointed by the President as may be necessary for the conduct of Chapter activities.

The terms of office for members of Chapter Committees shall end upon the discharge of the duties for which they were appointed, or at the next annual meeting of the Chapter, whichever comes first.

Section 8 - Election of Members Dues and Fees

The Executive Committee shall establish annual dues subject to approval of the members voting at the annual meeting.

Application for all classes of American Fisheries Society Chapter memberships may be received by the Secretary-Treasurer of the Chapter and shall be forwarded to the Secretary-Treasurer of the Society.

The Executive Committee may assess each registrant attending annual meetings of the Chapter a registration fee necessary to cover the costs of the meeting and Chapter activities. Collections shall be made by the Secretary-Treasurer and disbursements shall be made for financing the Chapter operations, as may be directed by the membership or by the authorization of the Executive Committee.

Section 9 - Voting and Quorum

Decisions at meetings of the Chapter shall be in accordance with Article IV, Paragraph 4, of the Constitution of the American Fisheries Society and the latest edition of Robert's Rules of Order.

A quorum at any meeting for the transaction of official business shall be one-third of the Chapter membership.

Business and voting may be conducted via mail or electronic media if approved by the Executive Committee.

Section 10 - Registration

The Executive Committee may assess each registrant attending annual meetings of the Chapter a registration fee necessary to cover the costs of the meeting and Chapter activities. Collections shall be made by the Secretary Treasurer and disbursements shall be made for financing the Chapter operations, as may be directed by the membership or by the authorization of the Executive Committee.

Section 140 - Amendments of the Bylaws

The Bylaws of the Chapter may be amended and approved in accordance with Article IV, Paragraph 4, and Article VI, Paragraph 3, of the Constitution of the American Fisheries Society and by Section 9 of these Bylaws.

The Bylaws of the Chapter may be amended by a two-thirds majority approval of those members voting, providing that prior notice of at least 30 days be given to the membership of the proposed change(s).

In accordance with the Society Constitution, an adopted amendment shall be reviewed by the Society's Constitutional Consultant for conformity with the Constitution, Rules and Procedures of the Society. The Constitutional Consultant presents the adopted amendment to the Society Governing Board for approval.

Said change(s) must be approved by the Executive Committee Governing Board of the Societybefore taking effect. Amendments take effect when the Unit receives written notice of their approval by the Governing Board from the Executive Director.

Oklahoma State University Student Subunit of the American Fisheries Society Bylaws

Amended August 8, 2005

Section 1 - Name and Objectives:

The name of this organization shall be the Oklahoma State University Student Subunit of the American Fisheries Society, and herein referred to as the Student Subunit.

The objectives of the Student Subunit shall be to facilitate meeting the objectives of the Oklahoma Chapter of the American Fisheries Society, and to encourage the exchange of information by student members of Oklahoma.

All activities of this Student Subunit shall conform with Student Subunit bylaws and procedures.

<u>Section 2 - Membership:</u>

Official members of the Student Subunit shall be composed of those Oklahoma Chapter of the American Fisheries Society members in good standing that are full or part time students. Non students of the Oklahoma Chapter of the American Fisheries Society interested in all phases of student concerns are encouraged to attend and participate. There will be no discrimination of race, sex, creed, color, age, veteran status, sexual orientation, or disability with the regards to the purpose of the organization.

Section 3 - Meetings:

The Student Subunit shall hold at least one meeting annually at a time and place designated by the Executive Committee. This meeting will usually be held at the annual meeting of the Oklahoma Chapter of the American Fisheries Society.

Section 4 - Officers:

The officers of the Student Subunit shall consist of a President, Vice-President, Secretary/Treasurer, and immediate Past-President, if available. Officers must be students of Oklahoma State University, and shall be elected at the annual meeting. All officers may hold their office for up to three terms. In the event of a vacant position, the Executive Committee shall appoint a qualified replacement to fill the unexpired term. In the event the President cannot fulfill his/her duties, the Vice-President shall take over and the Executive Committee shall appoint a new Vice-President for the remainder of the term. The term for all elected officers shall terminate immediately following the election and installation of new officers at the annual meeting. In the event of a cancellation of an annual meeting, the officers and the members of any committees shall continue to serve until the next scheduled meeting.

Section 5 - Duties of Officers:

The President of the Student Subunit shall preside at all meetings, serve as the chair of the Executive Committee, represent the Student Subunit at the Oklahoma Chapter of the American Fisheries Society functions, and make such appointments and perform other duties and functions as are outlined in the Student Subunit Procedures and others that are authorized and necessary.

The Vice-President shall assume all duties of the President in the event of the President's Absence or inability to act. He/she will also be responsible to duties of the Vice President as outlined in the Student Subunit Procedures.

The Secretary/Treasurer shall keep the official records of the Student Subunit and be custodian to all funds which may be allotted to the Student Subunit. He/she must submit a report on minutes of all meetings of the Executive Committee and other meetings. The Secretary/Treasurer shall consult with the Secretary/Treasurer of the Oklahoma Chapter of the American Fisheries Society and is authorized to disburse funds as necessary. The Secretary/Treasurer shall submit a record of receipts and disbursements at the annual Subunit meeting. He/she shall perform duties as may be requested by the Secretary/Treasurer of the Oklahoma Chapter of the American Fisheries Society. The Secretary/Treasure will also assume other duties as outlined in the Student Subunit Procedures.

<u>Section 6 - Executive Committee:</u>

The Executive Committee of the Student Subunit shall consist of the 3 elected officers and faculty advisor. The Executive Committee is authorized to act for the Student Subunit between meetings and perform appropriate duties and functions as described in the Student Subunit Procedures.

Section 7 - Student Subunit Committees:

The committees and Chair of the committees shall be appointed by the President as may be necessary for the conducting of the Student Subunit activities. The terms of office for members of the Student Subunit Committees shall end upon the discharge of the duties for which they were appointed, or at the next annual meeting of the Subunit, whichever comes first. Standing Committees help the Executive Committee conduct Subunit affairs annually. Special Committees are temporarily created for a specific purpose. Standing and Special Committees act and conduct duties as outlined in the Subunit Procedures.

The Student Subunit has established the following Standing Committees:

<u>Fisheries Techniques Demonstration Committee</u>: Composed of the committee chair (Student Subunit Vice-President), and at least two other Student Subunit members. The function of the committee is to organize and oversee all aspects of the Annual Fisheries Techniques Demonstration each spring.

<u>Section 8 - Election of Members:</u>

Application for all classes of American Fisheries Society memberships may be received by the Secretary/Treasurer of the Student Subunit and shall be forwarded to the Secretary/Treasurer of the Oklahoma Chapter.

Section 9 - Voting and Quorum:

Decisions at meetings are by simple majority of Active Members voting. A quorum for any meeting for the transaction of official business shall be at least five members. Voting rights are restricted to Oklahoma State University students only.

Section 10 - Registration and Dues:

The Executive Committee may assess each registrant attending annual meetings of the Student Subunit a registration fee necessary to cover the cost of the meeting and Student Subunit activities. Collections shall be made by the Secretary/Treasurer of the Student Subunit to be passed on to the Secretary/Treasurer of the Oklahoma Chapter.

Section 11 - Amendments of the Bylaws and Procedures:

The Bylaws of the Student Subunit may be amended and approved in accordance with Article VI, Section 4, and Article X, Section 1, of the Constitution of the American Fisheries Society, the bylaws of the Oklahoma Chapter of the American Fisheries Society, and by Section 9 of these Bylaws.

Procedures are the lowest level of documentation for Student Subunit operations. They are established to provide continuity in the conductance of Student Subunit operations. They are amended by a majority vote of the Executive Committee.

Southern Division Advances Action Plan For Hurricane Relief

On 29 August 2005 Hurricanes Katrina and Rita devastated large portions of Louisiana and Mississippi and caused significant impacts to Alabama, Florida and Texas. Collectively they are considered the largest natural disaster yet to occur in North America. Shortly thereafter, during the 2005 Annual Meeting of the American Fisheries Society (AFS) in Anchorage, Alaska, Parent Society AFS President Chris Kohler established the AFS Hurricane Relief Task Force and charged it to develop strategy for addressing professional needs of our fisheries colleagues impacted by the storms. The task force, chaired by Don Jackson (Mississippi Chapter) held its first meeting on 13 January 2006 on the campus of Louisiana State University. This post-Christmas date was scheduled in order to allow fisheries professionals in the impacted region opportunity to deal with personal and professional/agency immediate needs following the 2005 storms, and to move through a very stressful holiday season.

An action plan was drafted during the January task force meeting and, using the organizational structure of the American Fisheries Society, was subsequently presented in February to (1) the joint Annual Meeting of the Louisiana and Mississippi Chapters in Natchez, Mississippi and (2) to the Southern Division during its Annual Meeting in San Antonio, Texas. In order to ensure maximum participation by chapter members during the joint Annual Meeting of the Louisiana and Mississippi chapters, the Southern Division provided travel support for members of the Louisiana Chapter (who otherwise would not have been able to engage in out-of-state travel).

Following guidance from the chapters and the Southern Division, the Action Plan was modified and presented in March to the Parent Society Governing Board during its Mid-year meeting in Bethesda, Maryland. On 11 March 2006, The Governing Board approved the Action Plan.

The Action Plan

- 1. AFS assigns the Southern Division (SDAFS) with administrative and programmatic responsibilities to implement relief to AFS members in the Gulf Coast region impacted by Hurricanes Katrina and Rita.
- 2. Upon approval of the SDAFS leadership, complimentary memberships and online journal subscriptions will temporarily be provided (duration to be determined) to AFS members identified by their respective AFS Chapters as having been impacted by Hurricanes Katrina and Rita.
- 3. Upon approval of SDAFS leadership, travel funds to attend AFS annual meetings will be provided to AFS members identified by their respective AFS Chapters as having been impacted by Hurricanes Katrina and Rita.
- 4. SDAFS will assist with the establishment, maintenance, and staffing of a program to facilitate linkages

between AFS members identified by their respective AFS Chapters as having specific professional and/or programmatic needs resulting from Hurricanes Katrina and Rita with AFS members/units who have resources to address these needs.

- 5. AFS will provide a maximum of \$30,000 to SDAFS to address the above actions for the period 15 March 31 December 2006.
- 6. The AFS Hurricane Relief Task Force, along with the SDAFS, will report to the AFS Governing Board at the annual meeting in Lake Placid in September 2006 on the status of the on-going relief efforts and provide recommendations for future disaster relief programs and actions.

The task force held its final meeting on 18 May 2006 on the Louisiana State University Campus and, in accordance with the Action Plan and AFS Governing Board directive, transferred the program to the Southern Division. Chapters now have the responsibility of identifying AFS members who need assistance in terms of membership dues, journal subscriptions and travel support to AFS meetings and for forwarding recommendations for assistance to the Southern Division. The Mississippi Chapter will secure storage facilities to warehouse donations earmarked through the distribution program for colleagues needing these materials. The Texas Chapter and Parent Society Computer Users Section is developing the computerized network for matching donations with recipient requests. Don Jackson (Mississippi Chapter) will serve as the interim director for the distributions center and as liaison between chapters and the Southern Division regarding hurricane relief.




