President's Message:

Greetings, OKAFS members. Although the Oklahoma Chapter includes members with a diversity of careers, from young students to grizzled professors and agency folks, I imagine we've all had similar moments of doubt when we wondered about the gravity or purpose of our chosen profession: fisheries. Whether it's crippling impostor syndrome, where the challenges of your studies, career, or profession ahead seem an impossible task for someone with your skills and experience... or the opposite... where you wonder if your job and your efforts went away, would anyone actually notice? Or would mother nature just keep on trucking? No, you're not on the verge of a mental crisis. I think it's healthy for all of us to do some self-reflection on occasion. Thinking about why you are in the profession of fisheries... what are the realistic (lasting?) impacts of your concentrated thoughts and efforts? All those hours/years thinking about fish, collecting data, writing reports or papers... what will come of it? Hopefully, positive change. Change that lasts long after your career is over. Sometimes, it seems, the challenges are too big for one person to really make an impact. However, when the efforts of a bunch of fisheries folks are aggregated, say within the Oklahoma Chapter of American Fisheries Society, the positive impacts are multiplied.

It's crazy for one person to try to confront alone the environmental and other challenges to the fisheries within our state, much less worldwide. If we were all so blessed to be responsible for our own little spring-fed lake, shielded from outside influences, we could research, restore, augment, whatever that aquatic ecosystem and its fisheries community to our heart's desire. The impacts would likely be readily observable. Perhaps the trout or bass anglers on Facebook would actually be satisfied. In reality, we as fisheries professionals are dealing with complex ecological systems—global climate change (with its increasing floods and shifting thermal/discharge patterns), water shortages, and invasive species—in addition to myriad other anthropogenic impacts on those systems.

You may have seen a recent study on the essentially universal detection of "forever chemicals" at harmful levels in the flesh of freshwater fishes across the United States. It's reasonable to wonder if the amazing aquatic biodiversity of our state's waters will eventually yield to intersex copi-riding zebra mussels in a warm, oily soup of lead, microplastics, and PFAs. While this is hopefully a farcical prediction and a dramatic deviation from the little spring-fed lake of angler bliss, our current and future reality in Oklahoma fisheries likely lies somewhere in between.

In a 1970 article, Barry Commoner, a prominent environmentalist and the author of The Closing Circle, stated that, "The first law of ecology is that everything is connected to everything else," encapsulating a concept perhaps pondered by even the earliest in fisheries. An optimist would view the fact that everything is connected in fisheries as an ease of one's burden as a lowly fisheries student/professor/biologist/etc. in tackling the massive challenges highlighted above. Just as everything is connected in the ecosystems we love and study, those connections expand to include us, as fisheries professionals. The collective efforts, knowledge, and experience of fisheries professionals, additive and perhaps multiplicative since time immemorial, are daily making us better equipped to confront these challenges. The Oklahoma Chapter of the American Fisheries Society serves as an aggregating network to connect all of us as fisheries professionals in this state. It exists as a local extension of the parent society to foster scientific interaction, cooperation, and local advocacy for the fishes. Together, we are better equipped to confront challenges that are bigger than ourselves. I look forward to another year of collaboration and networking with fellow members of OKAFS. Thank you for being part of this organization and I hope to see you at the annual meeting August 28-30, 2023 at Lee's Resort on Grand Lake, if not before then. Keep up the great work.

COMMUNICATIONS COMMITTEE

The OK AFS Communications Committee (Jim Long [chair], Abby Johns, Daniel Fenner, Jon West and Nathan Copeland) met on October 31, 2022, to discuss the status of the new email listsery, ways to increase member engagement with each other and the chapter, and the status of the newsletter. The listsery operated by eMailDodo was compromised, and AFS set up chapters with access to a new service: SimpleLists. Posts have already been conveyed through SimpleLists, so it appears to be working well. If a member wants to post something to the list, an email can be sent to any of the chapter ExComm or the Communications Committee Chair. Posting by the membership at large is not enabled.

Member engagement is a focus of President Schooley, and the committee talked about the Twitter handle that the chapter maintains, the webpage, and the newsletter (The Lateral Line). The Twitter page is not very active, but keeping the handle for the future, such as when the chapter will be in charge of an SD AFS meeting, may be useful. With the pandemic, the webpage became stagnant, but we've updated it with current content. Check it out at https://units.fisheries.org/okafs/. In the future, we hope to work on additional tools for engagement. Emails, even from the listsery, can become overwhelming if a lot of content is delivered that way. Currently, the committee is looking into alternatives such as Slack channels (https://slack.com/) or creating a discussion board, such as the kind used by the North American Native Fish Association (http://forum.nanfa.org/). The listsery is a good mechanism to deliver information to the membership from the top down, which is necessary, but an additional tool to encourage more interaction among members would need to be something different. Let us know if you have any opinions about these options for helping members engage with each other.

Lastly, we spoke with the OSU Student Subunit, who produces the newsletter. They intend to put out a newsletter twice per year. Depending on when the annual meeting occurs, the newsletter is meant to provide a mechanism to distribute information before the meeting, including information such as dates and venues of the meeting, including a call for presentations. Also, the newsletter will serve as a vehicle for letting the membership know what happened at the last meeting (officer election, status of funds, award winners, etc.).

ODWC Internship Opportunities

The Oklahoma Department of Wildlife Conservation has established an Internship Program to help students that are majoring in wildlife related fields to gain work experience. The Department has a limited number of internship positions available. Positions are seasonal and vary by location and duration.

Internships are primarily in the spring and summer, with occasional fall positions. Locations are state-wide. Work schedules will be determined by the supervisor. Positions will be limited to two terms not to exceed 975 hours per term. (a term is a 12-month period starting with the hire date). A 3rd term may be worked only if the Intern is continuing their education. Verification must be submitted if rehired for a 3rd term. Lodging is not provided.

Intern applicants must be actively pursuing a degree, or have obtained a degree, in the following college majors:

- Wildlife Conservation Science
- Wildlife Ecology Education
- Biology
- Zoology
- Other related wildlife degrees

Graduate degree candidates, seniors, juniors, and sophomores with majors in wildlife conservation and those with previous related work experience in fisheries or wildlife will receive preference.
