PRESIDENTS CORNER

My term as President of the Western Division is rapidly coming to a close. as a Division have met two of the three objectives that we established at our annual meeting last year. The Riparian Committee, chaired by Don Duff, will have their Best Management Practices paper completed by July of 1981; and the Acquisition and Utilization of Aquatic Habitat Inventory Symposium, coordinated by Neil Armentrout, is to be held in Portland, Oregon, on October 28-30. RIPARIAN HABITAT COMMITTEE Don Duff is completing his second year as Chairman of this committee. The committee was divided into 3 sub-committee in 1980-81 because of its workload and interest by Western Division members in participating. Major emphasis this year has been placed on development of Best Management Practices (BMP's) for riparian areas as a followup to the Committee position paper last year which the Western Division approved at last years annual meeting. The sub-committee co-chairman Jim Cooper (USFS) and Art Anderson (FWS) who have the lead in preparing a listing of BMP's are working with their committee members to prepare a draft BMP listing for the EXCOM's review at the annual meeting in Hawaii. If approved, the BMP's could be issued by the Division in the same manner as the position paper and serve as a useful tool for land managers to use for guidance in riparian area management.

The second sub-committee chairman John. Rinne (USFS) and his members have been monitoring the status of agencies compliance with environmental laws giving emphasis to riparian area management. A report from this group will be presented in the full Committee report to the EXCOM. A third-subcommittee under chairman Ron Remmik (WYO Dept F&G) is busily developing a draft. narrative for a slide-tape module depicting the status and history of riparian area management in the West. This work will continue into the 1981-82 year and lead to completion of a finalized slide-tape module

for the Division, hopefully, in 1982. All members of these committees are to be commended for their interest and dedication to the cause of riparian area management. I and the EXCOM have appreciated their efforts as well as contributors of Division non-committee members, and hope all will continue their participation on the Riparian Habitat Committee in 1981-82. ACQUISITION AND UTILIZATION OF AQUATIC HABITAT INVENTORY INFORMATION October 28-30 1981 Portland, Oregon

New techniques are being developed for the inventory of aquatic resources, evaluation or information, and the use of information in making resource management decisions. This symposium will provide an opportunity to discuss recent advances and state of the art for aquatic habitat inventories.

Topics will include:

Defining the aquatic ecosystem and its individual components; Methodology for measuring the habitat components; Relating habitat components to species utilization; Interfacing aquatic habitat inventories with other resource inventories; Using habitat inventory information to evaluate habitat condition and potential; The use of inventory information and evaluation procedures in aquatic habitat classification systems; The use of inventory data and evaluations in resource planning and impact anaylsis; Data storage, retrieval and analysis systems.

Two other program items to be included will be a "film festival" of films and slide-tapes concerned with aquatic habitat inventories. The second is a demonstration of computer systems or models for the storage and use of inventory information.


